

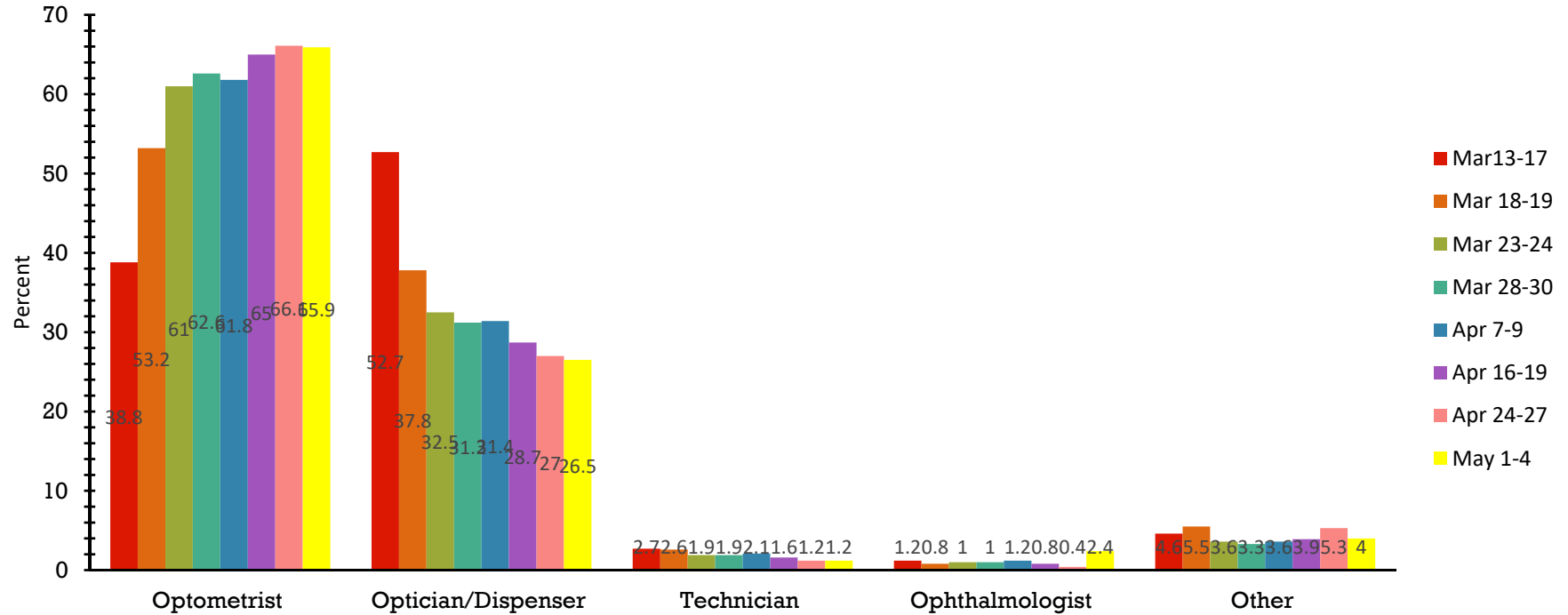

Coronavirus ECP Survey - Wave 8

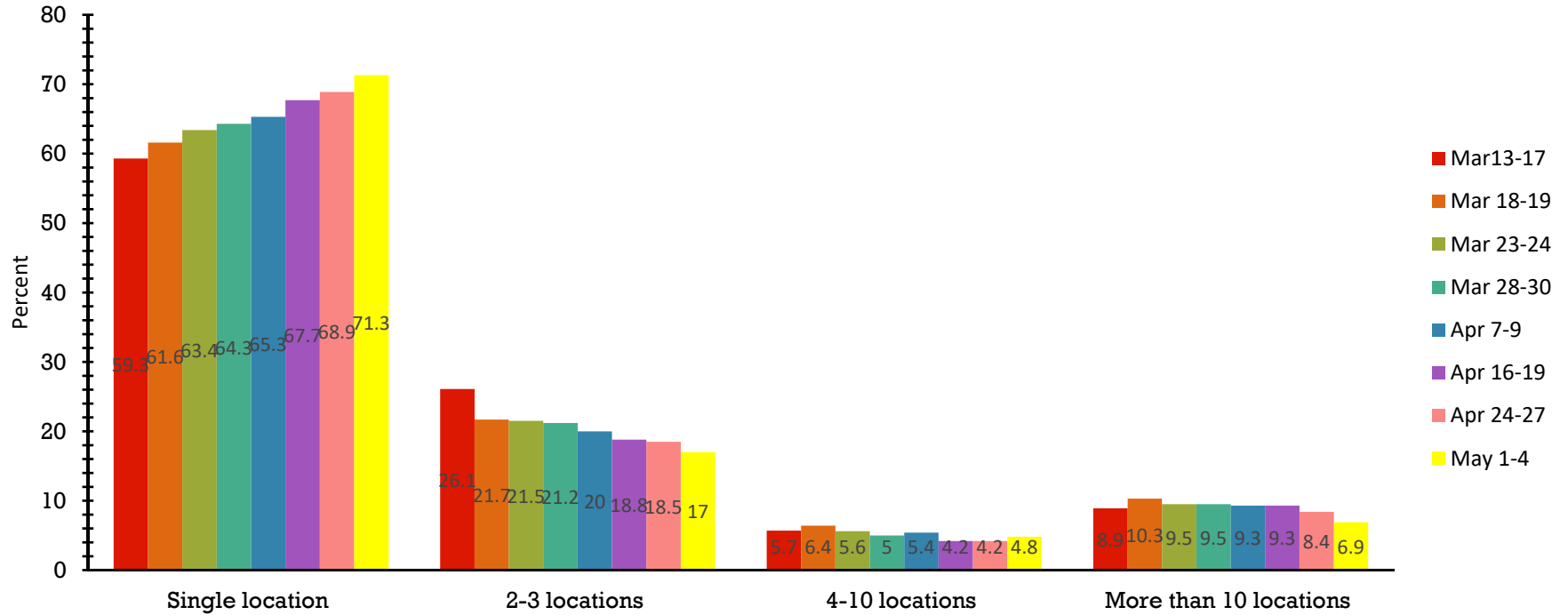
Respondents

- Comparisons are shown wherever possible.

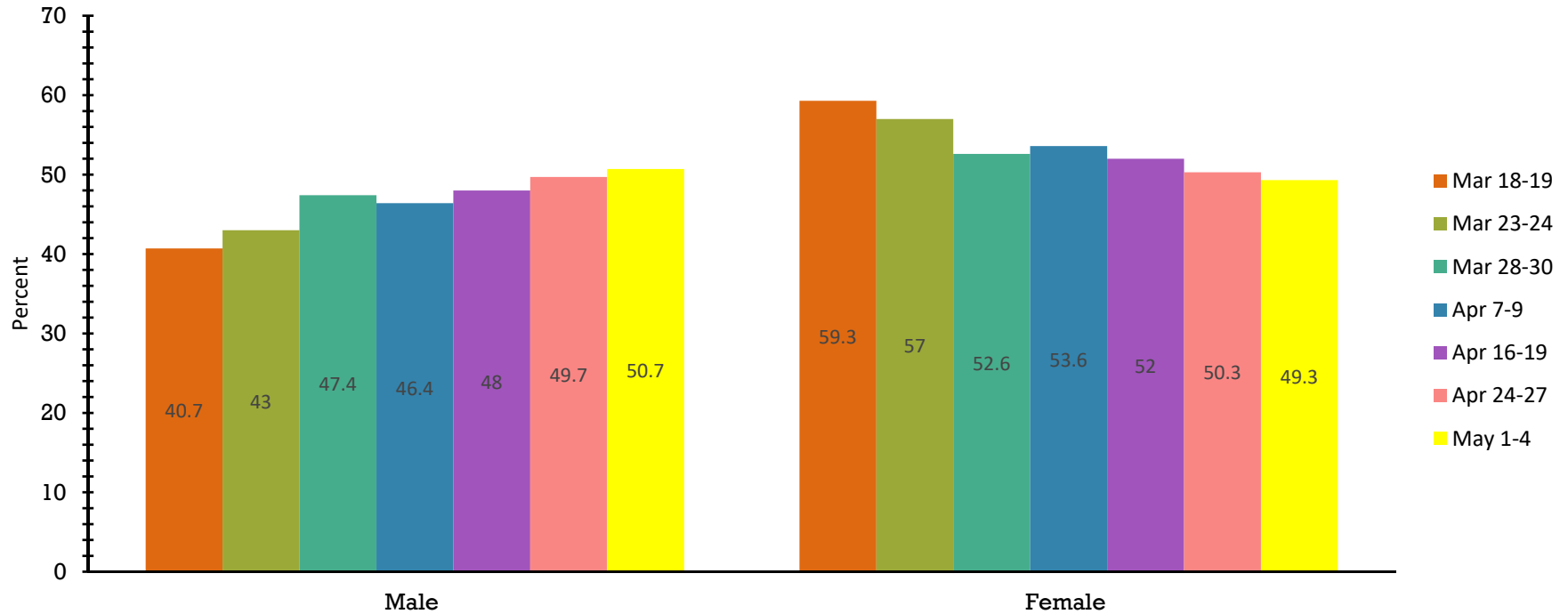

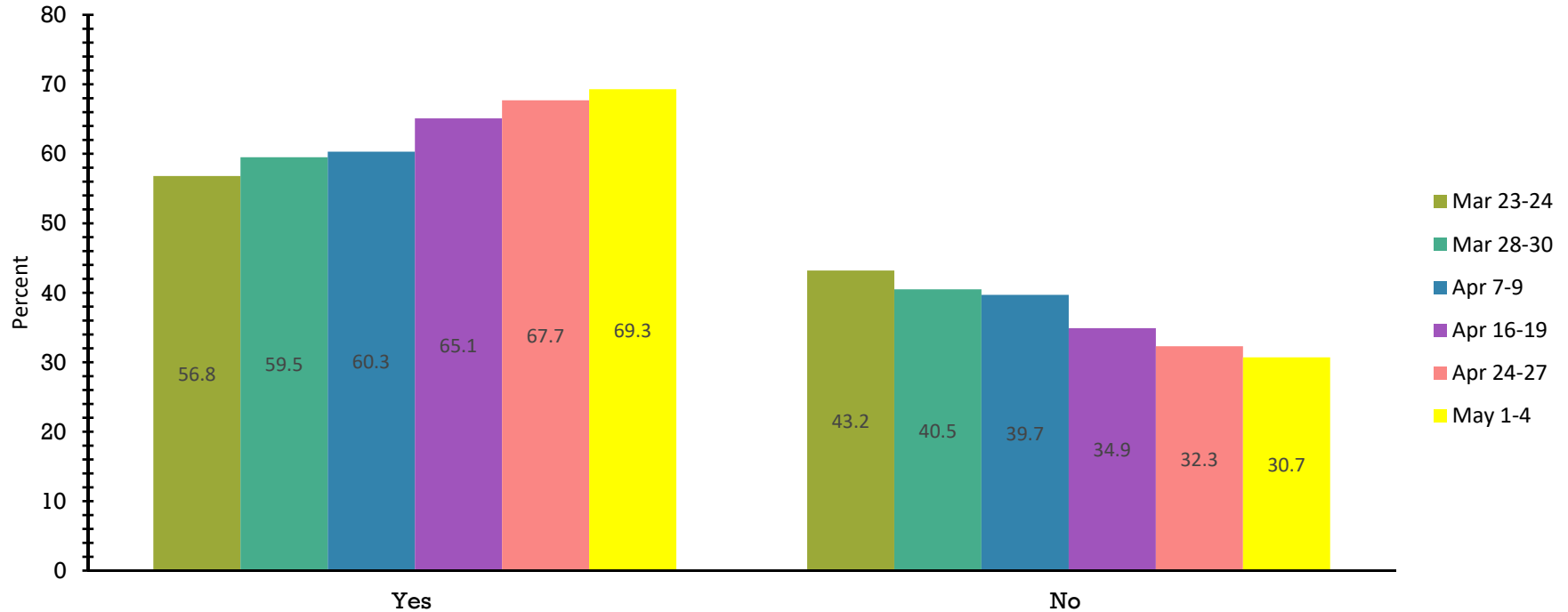
How many locations are associated with the location you primarily work at?



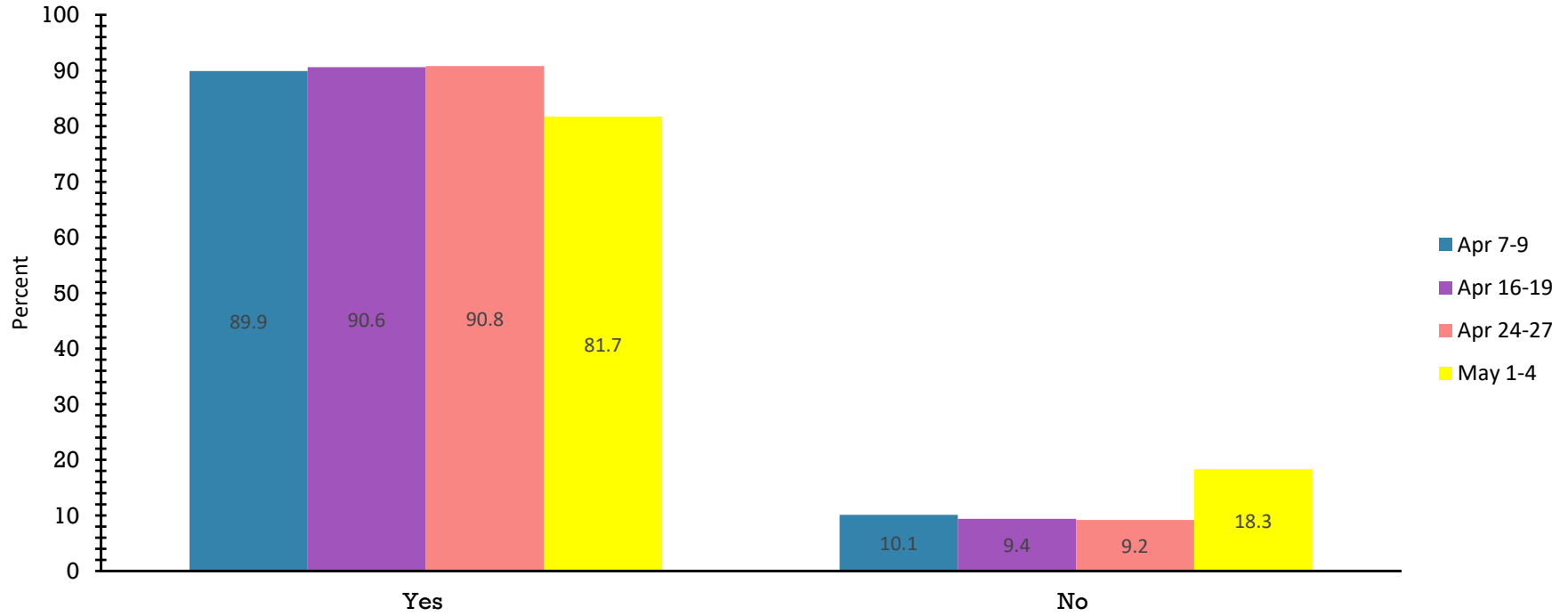

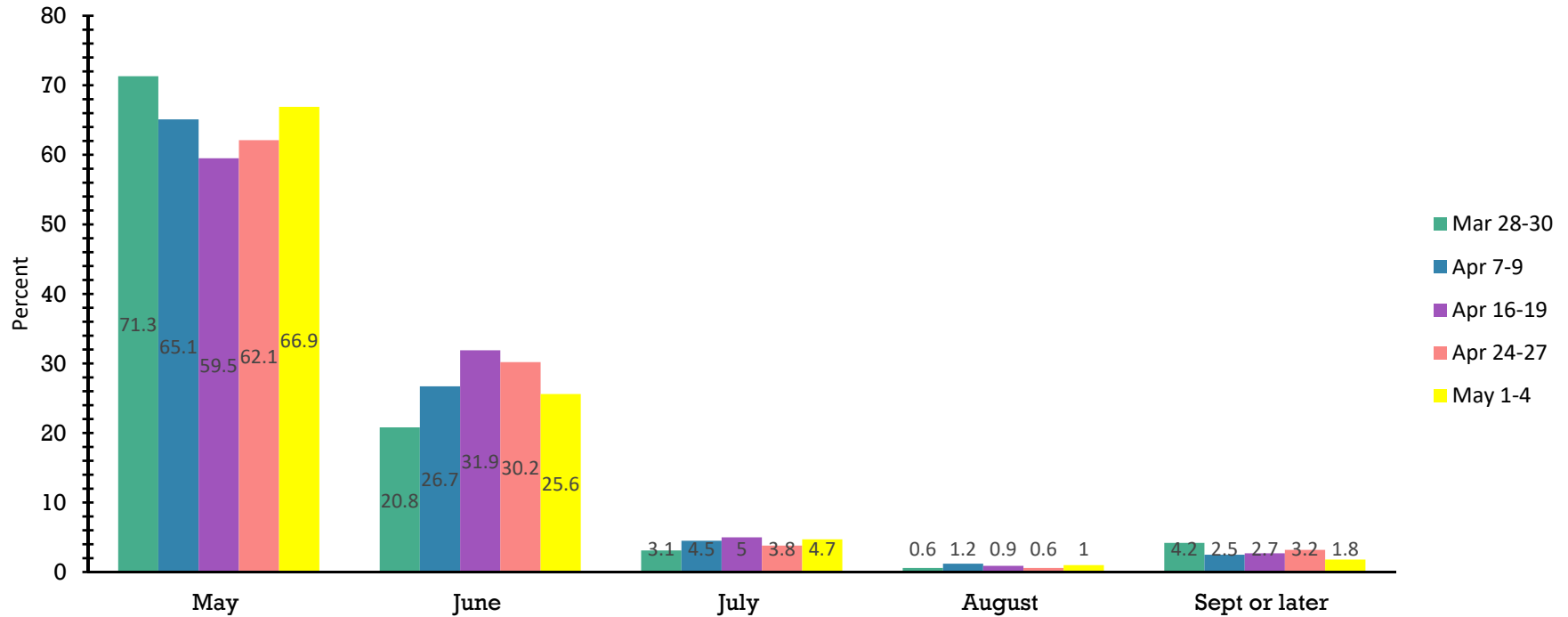

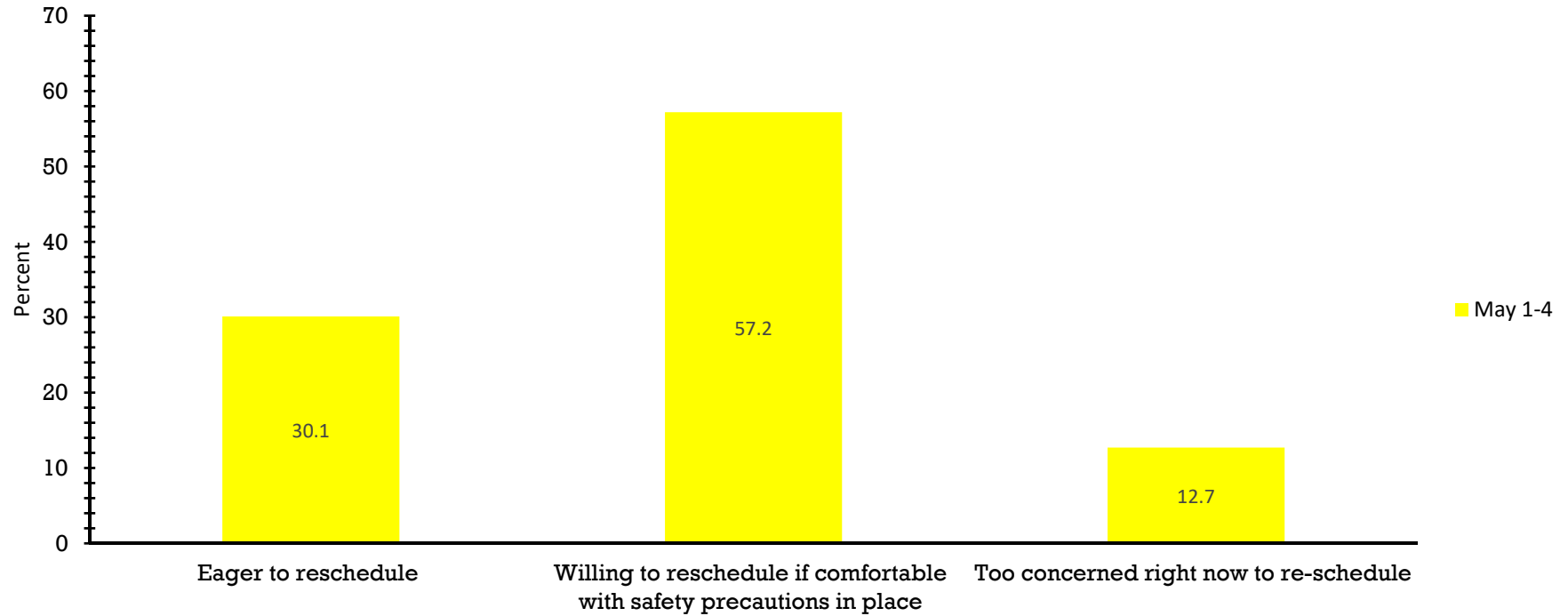

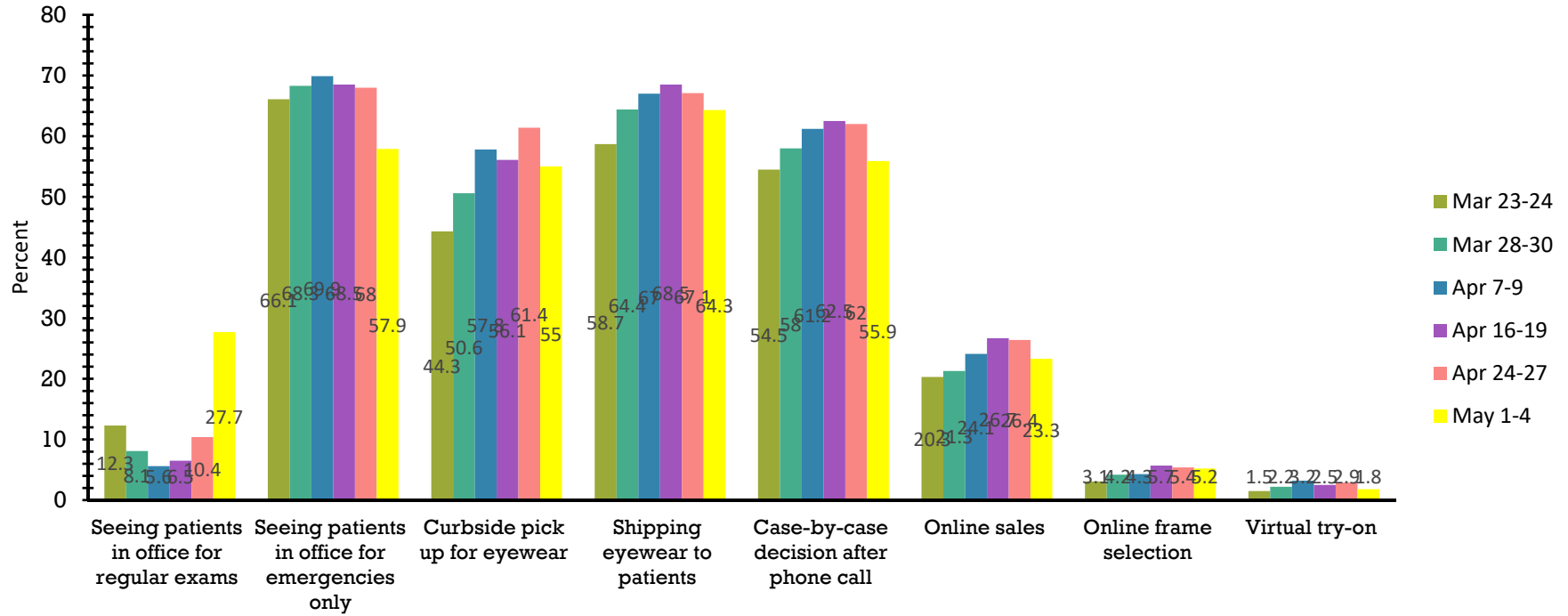

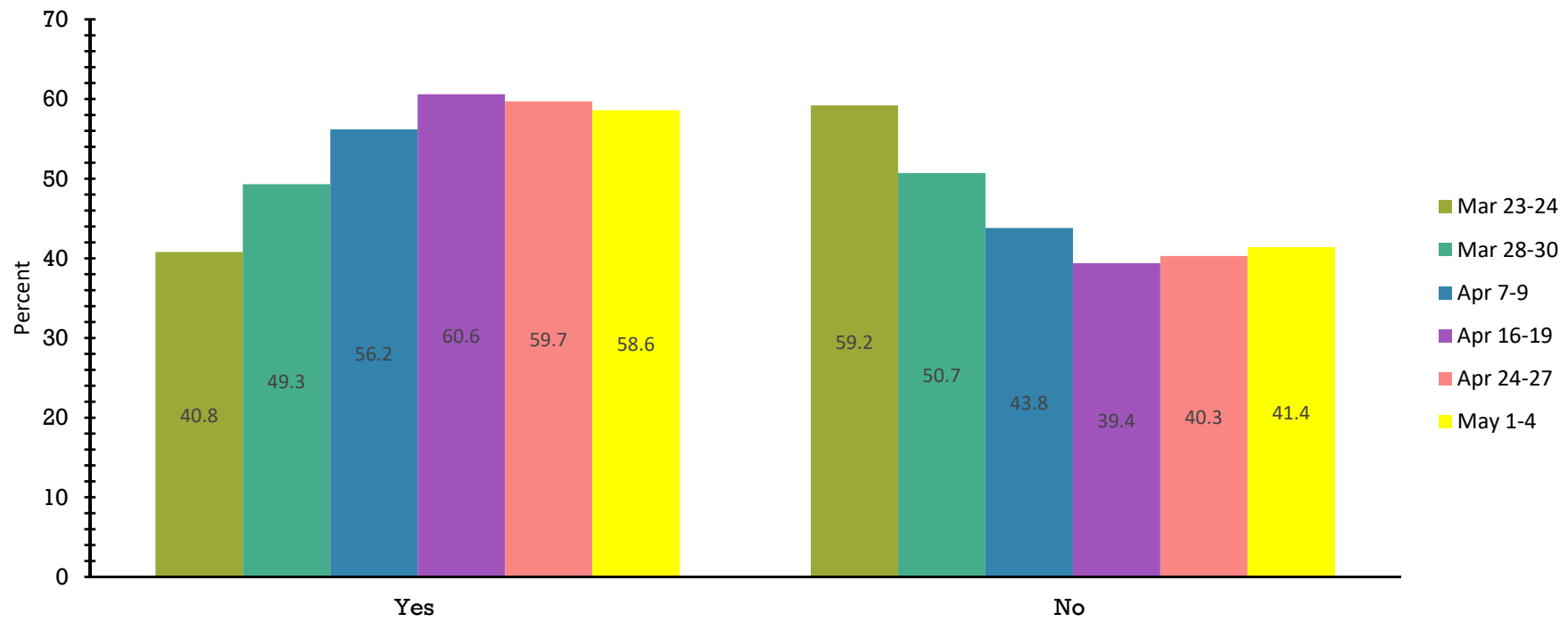

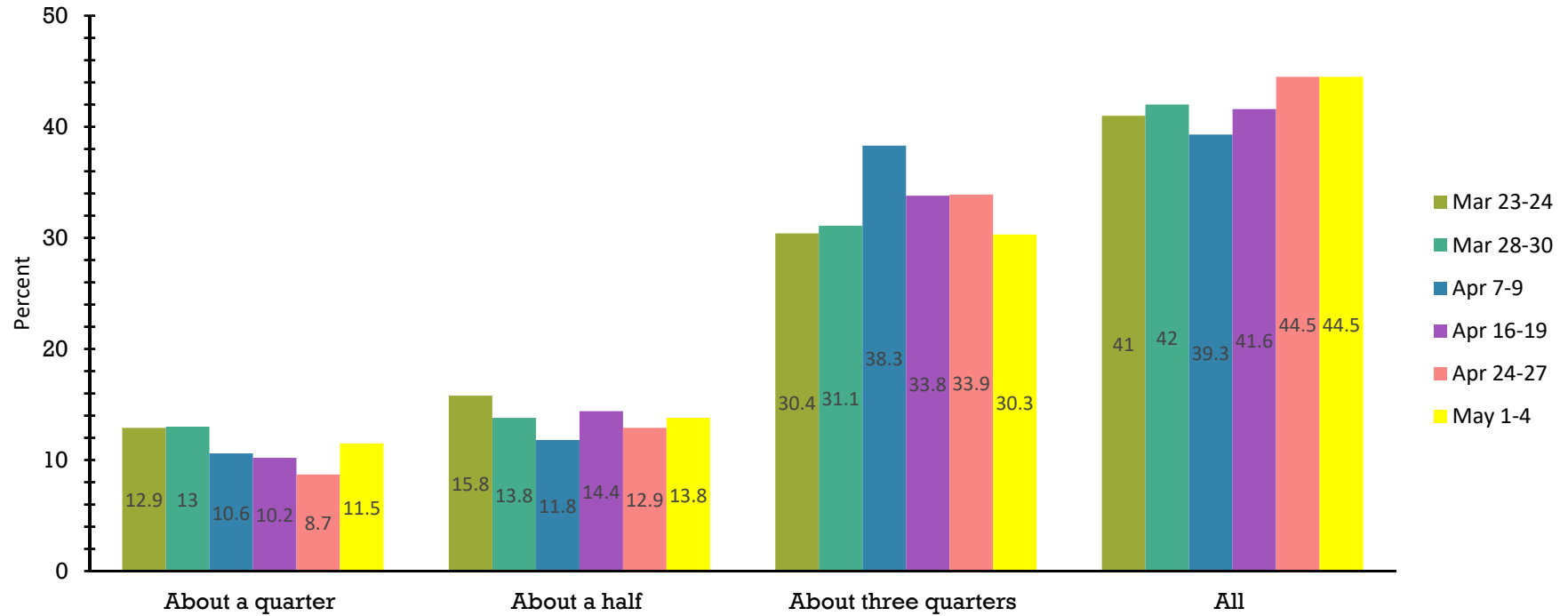

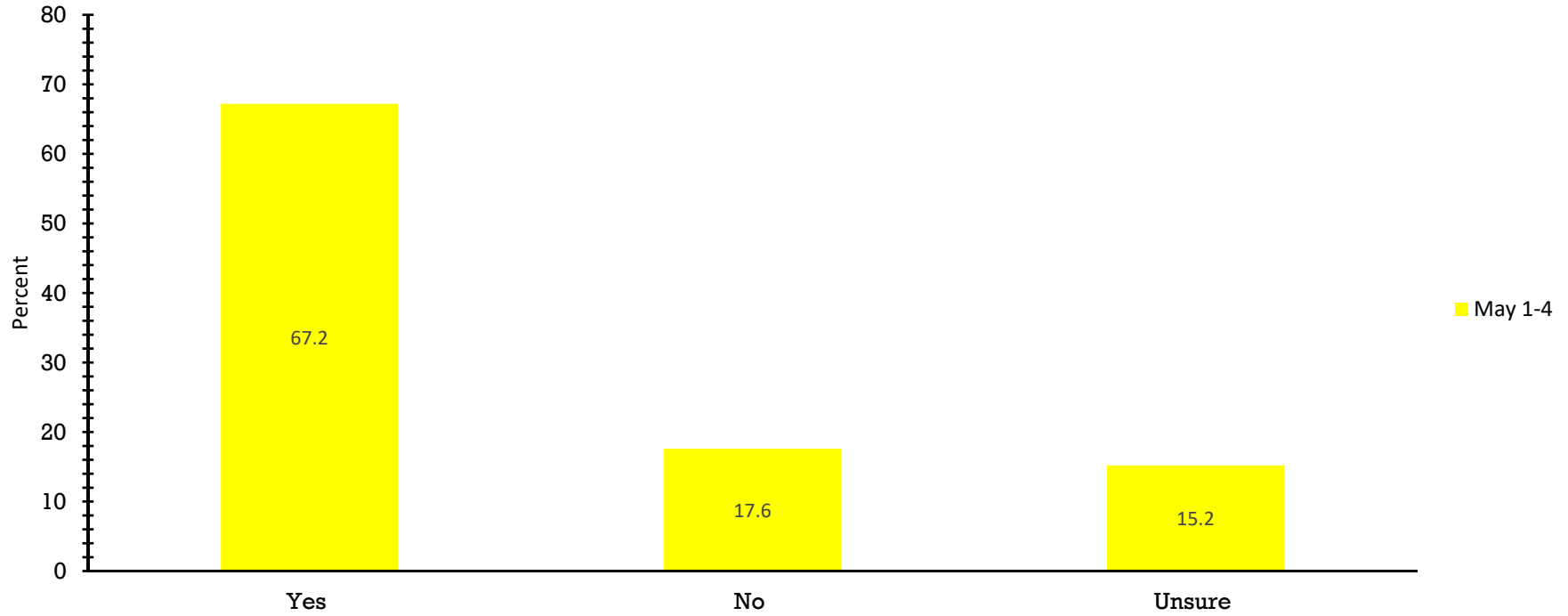

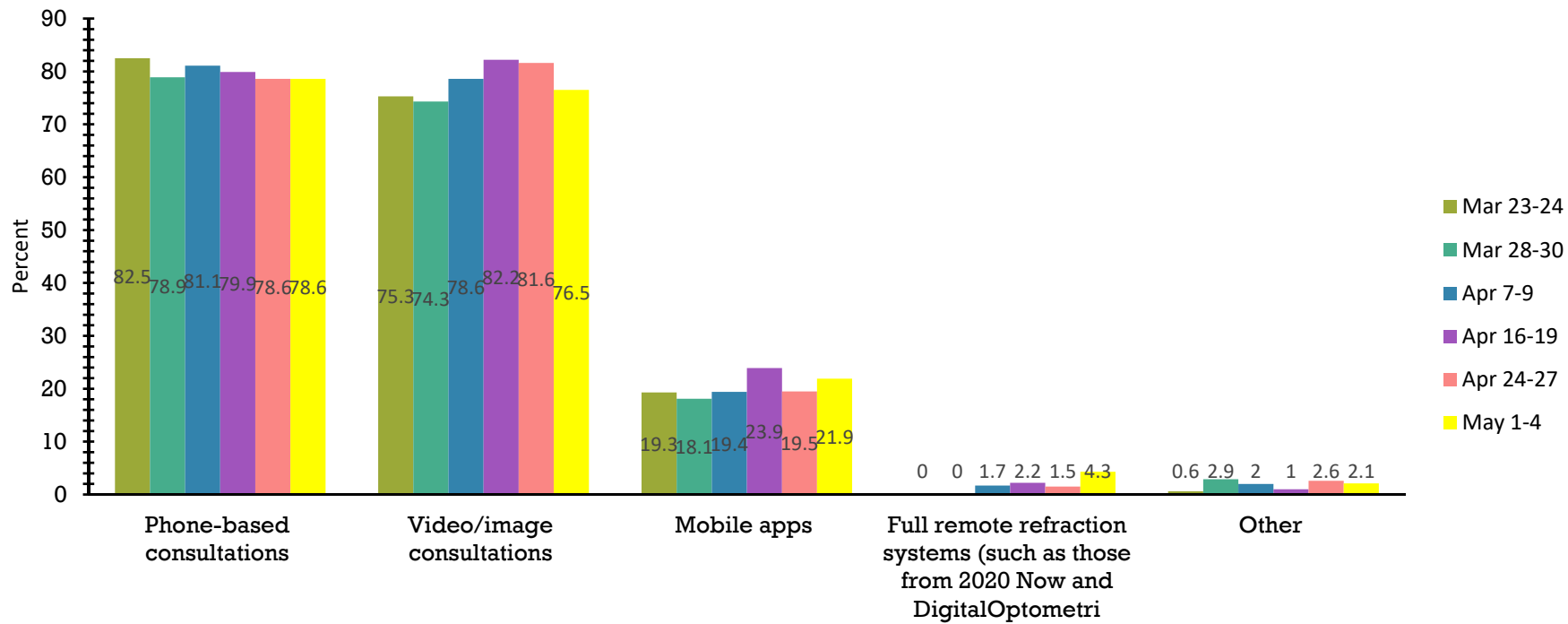

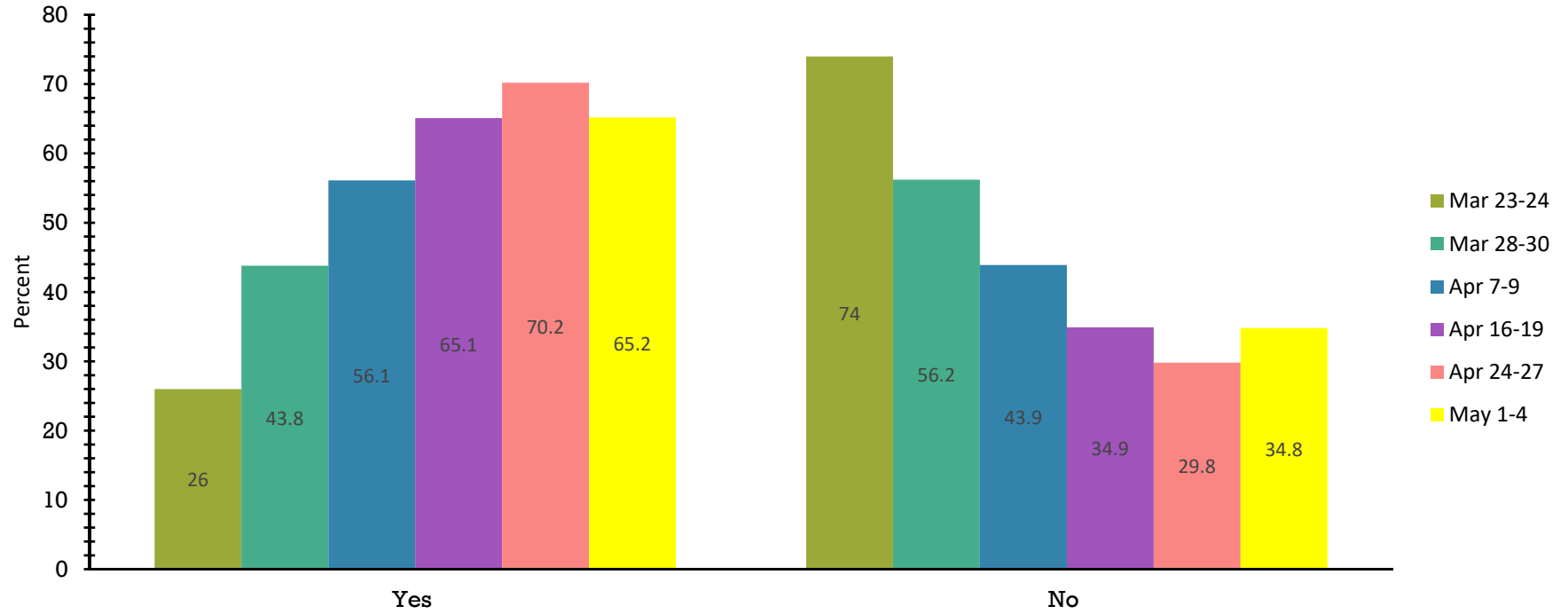

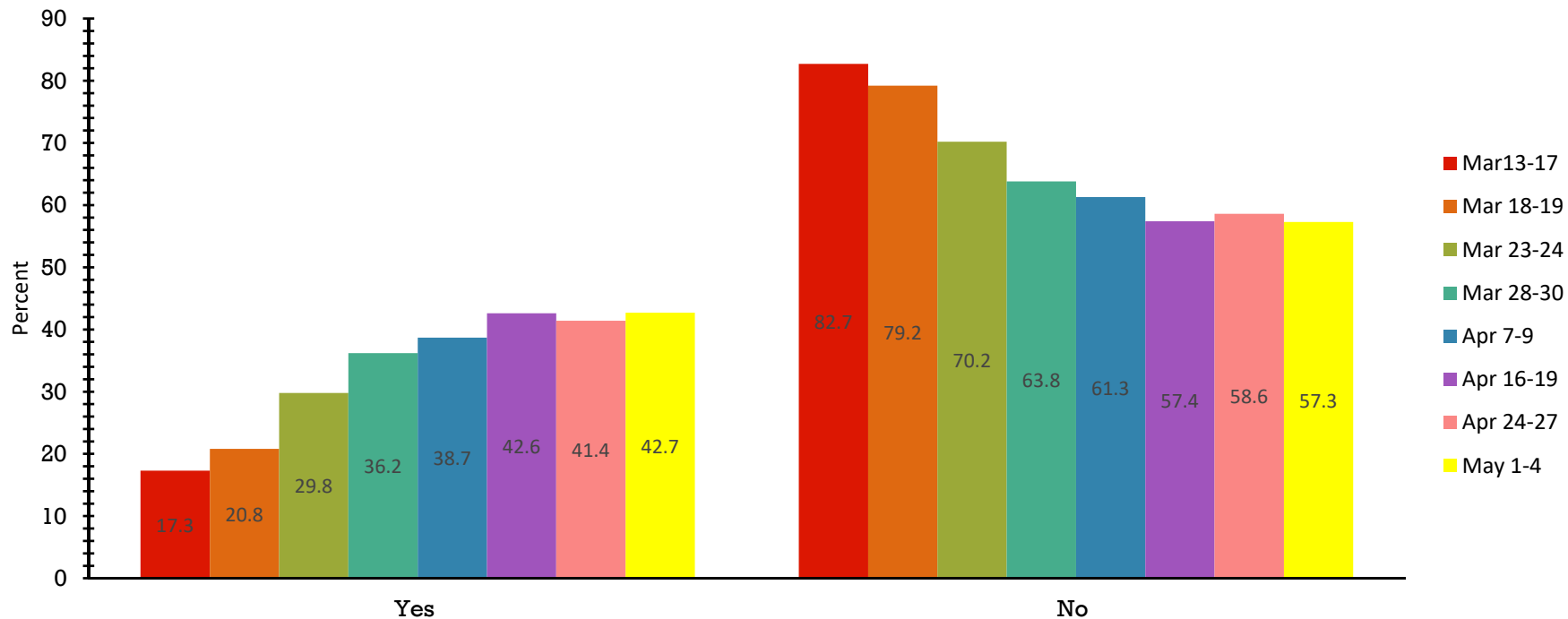

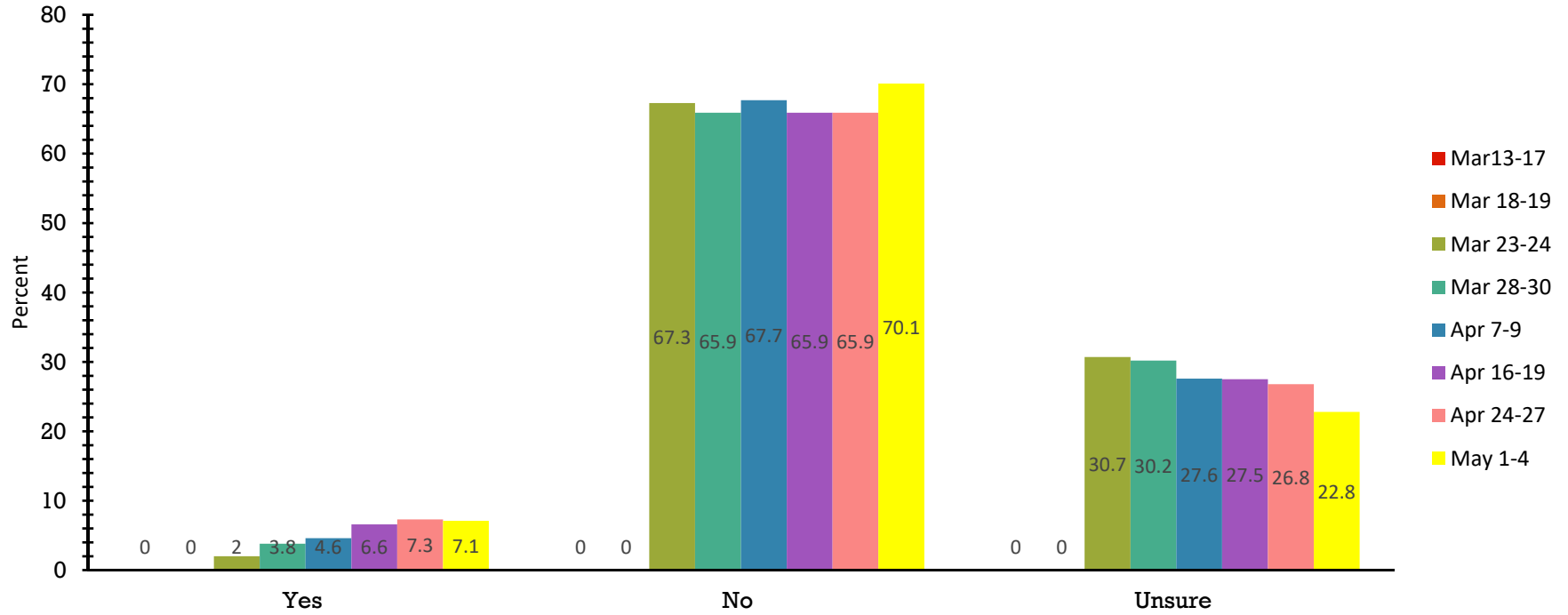

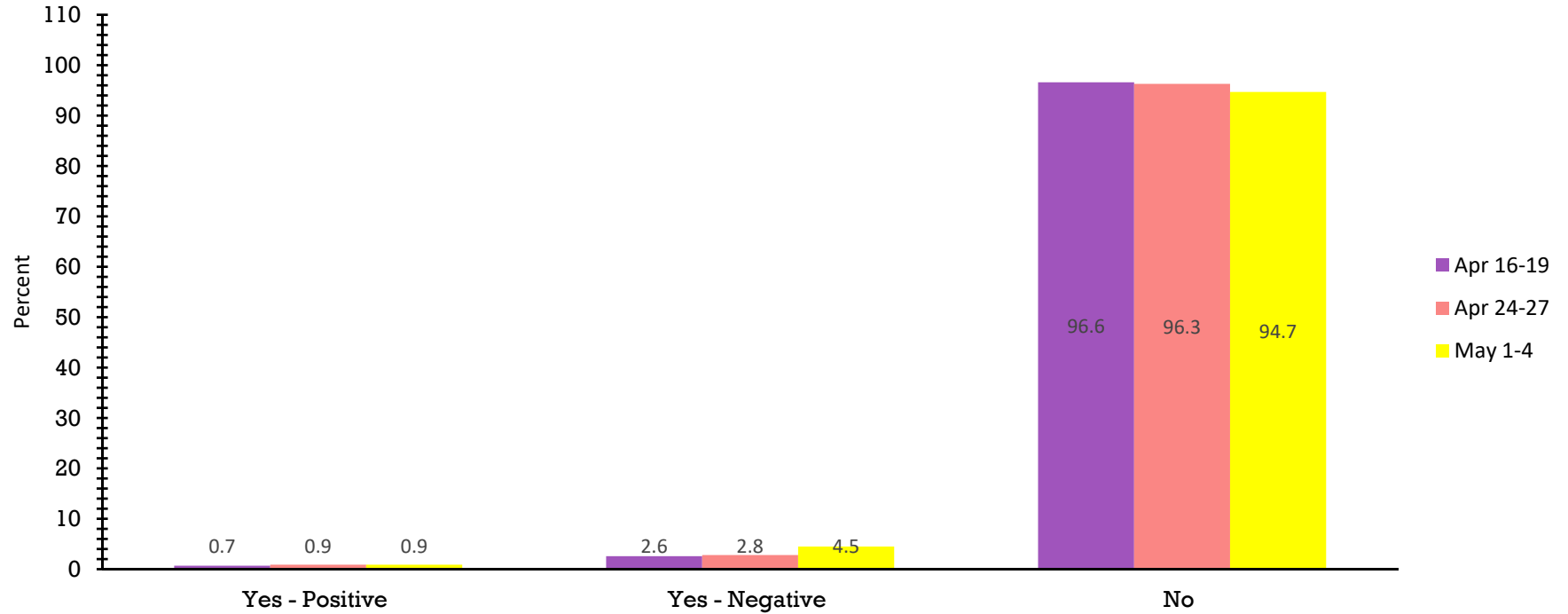

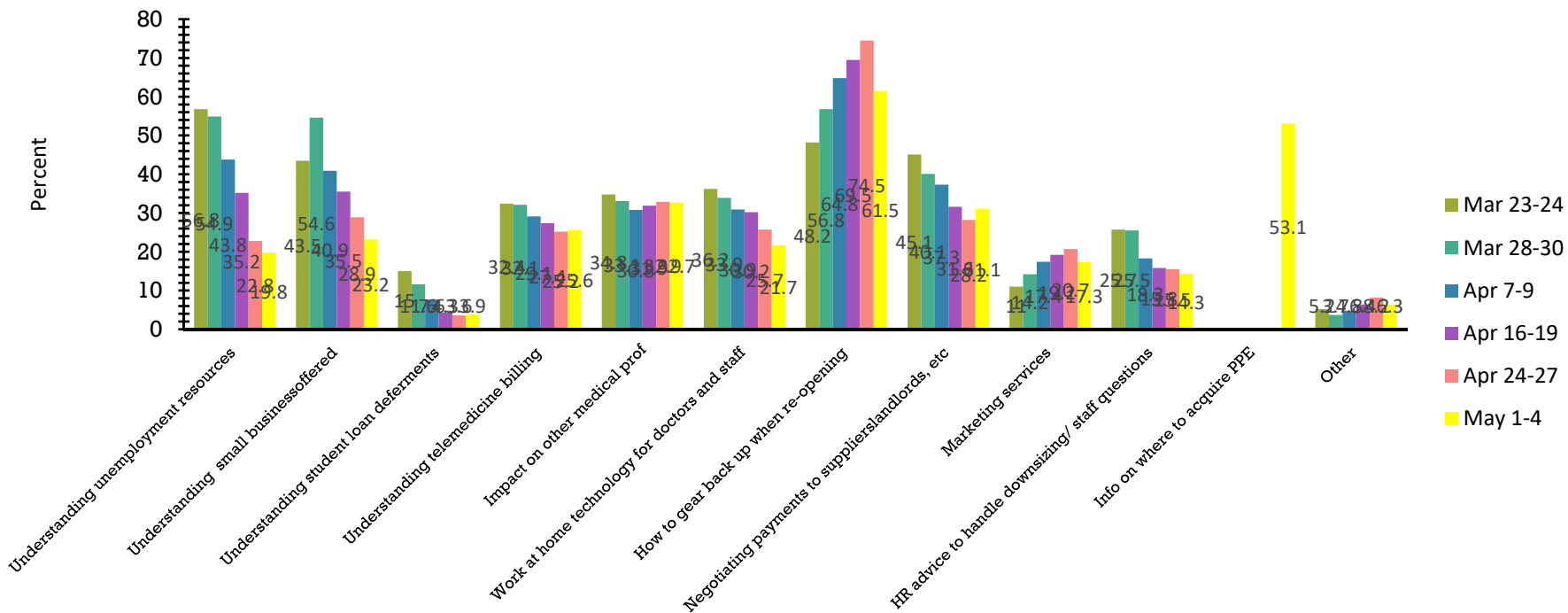

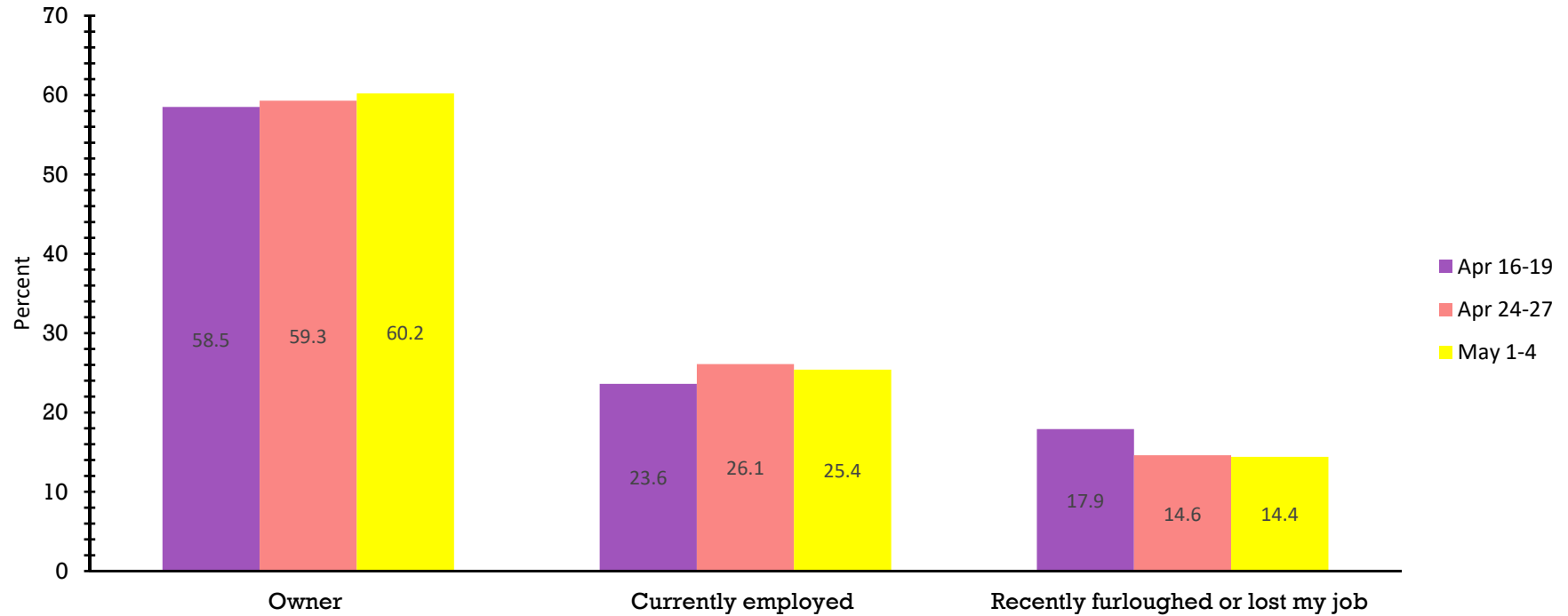

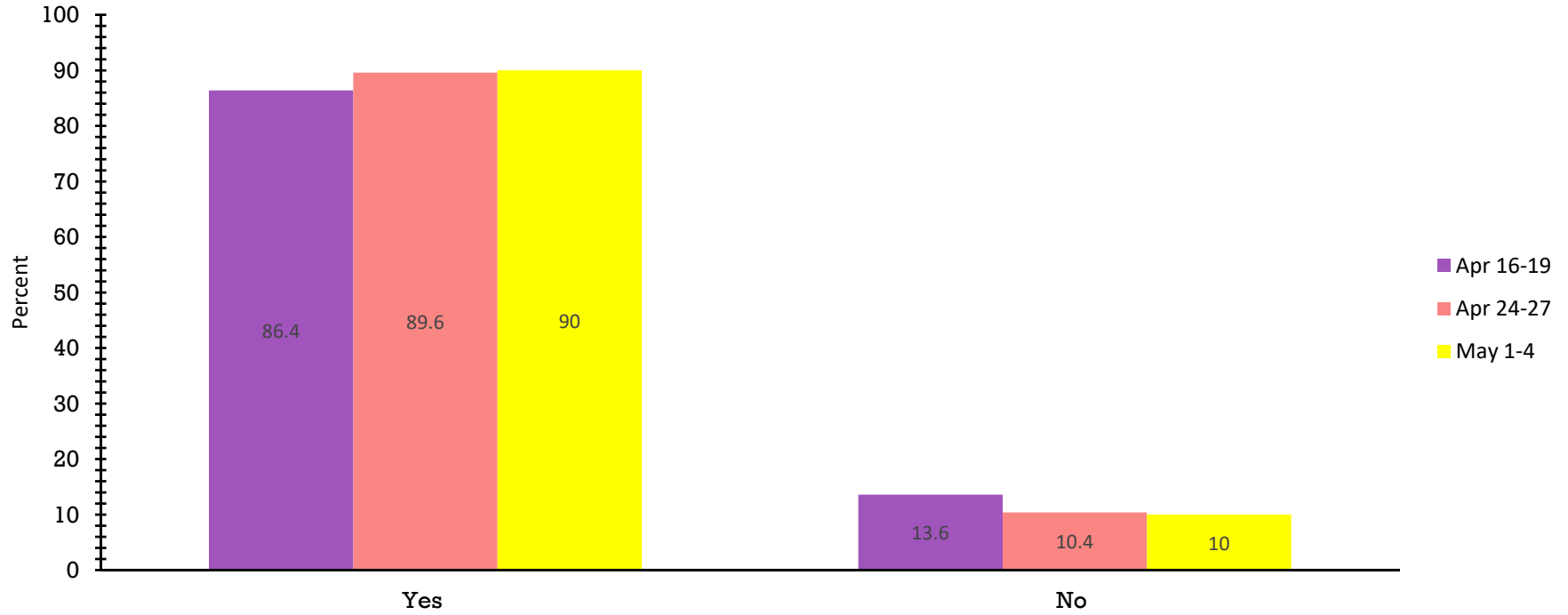

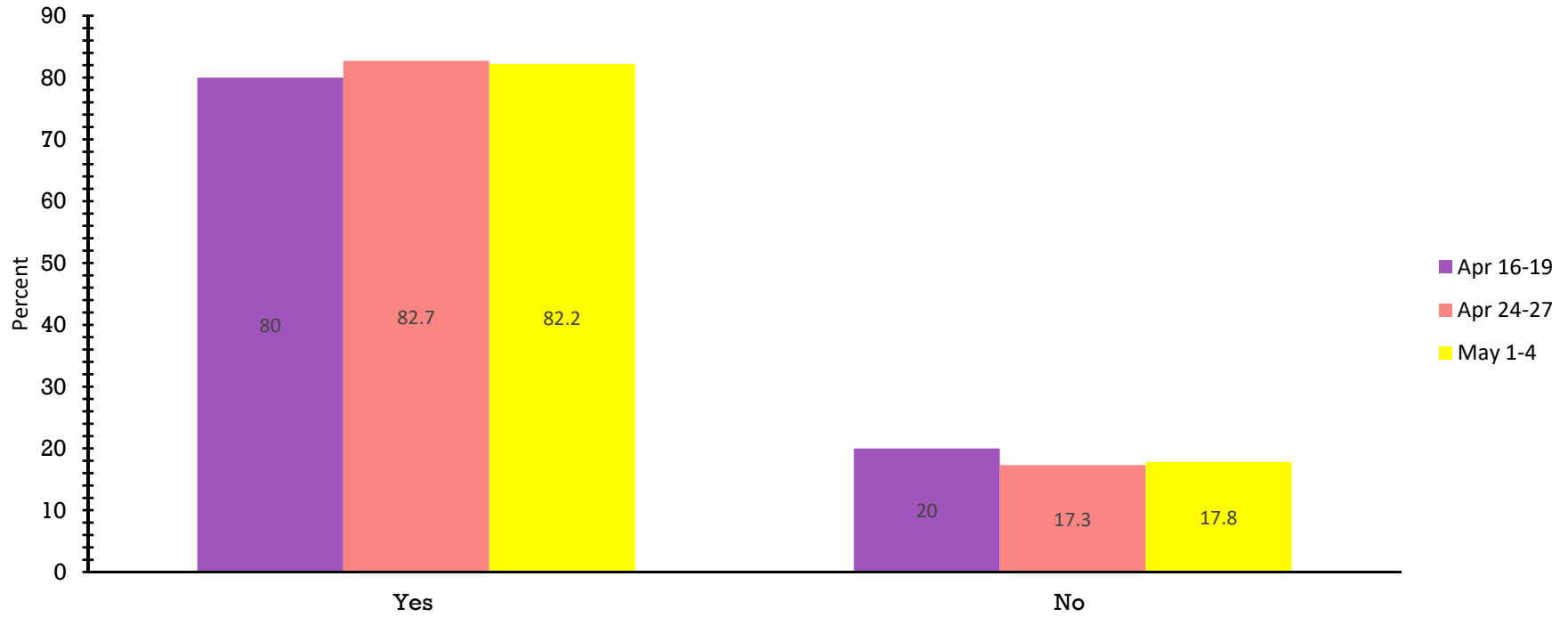

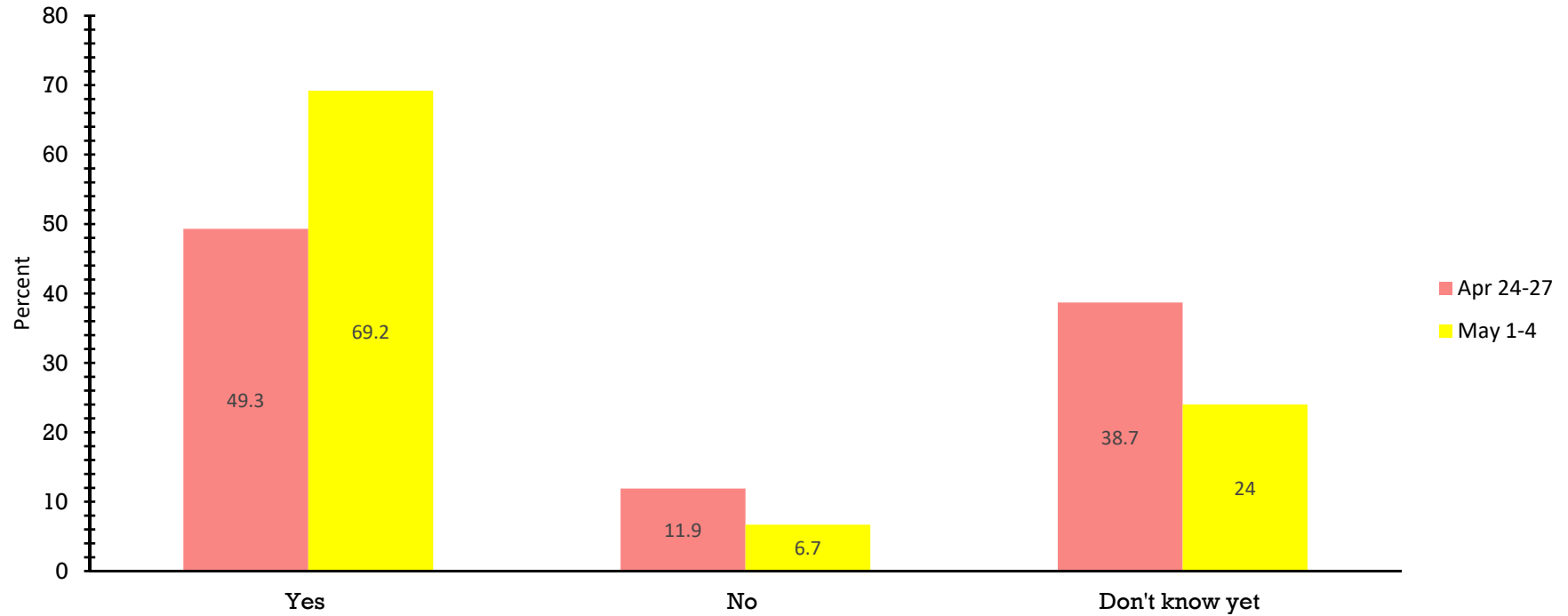

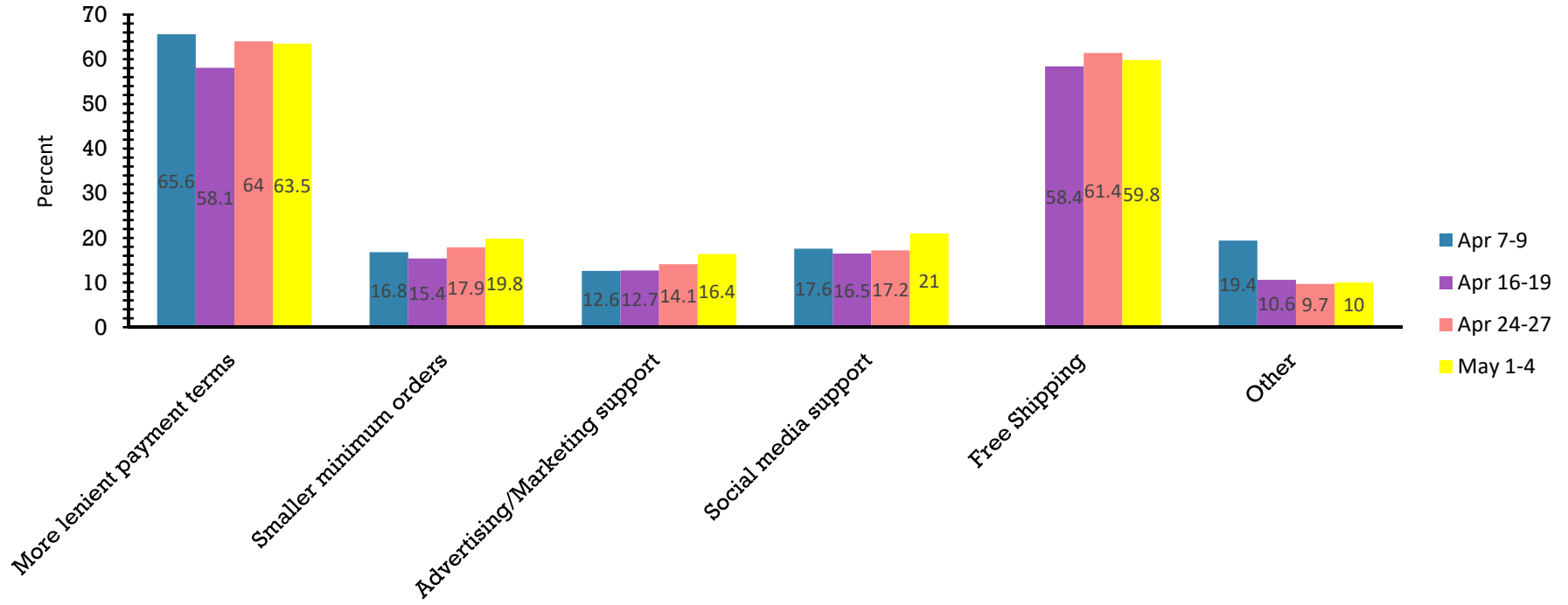

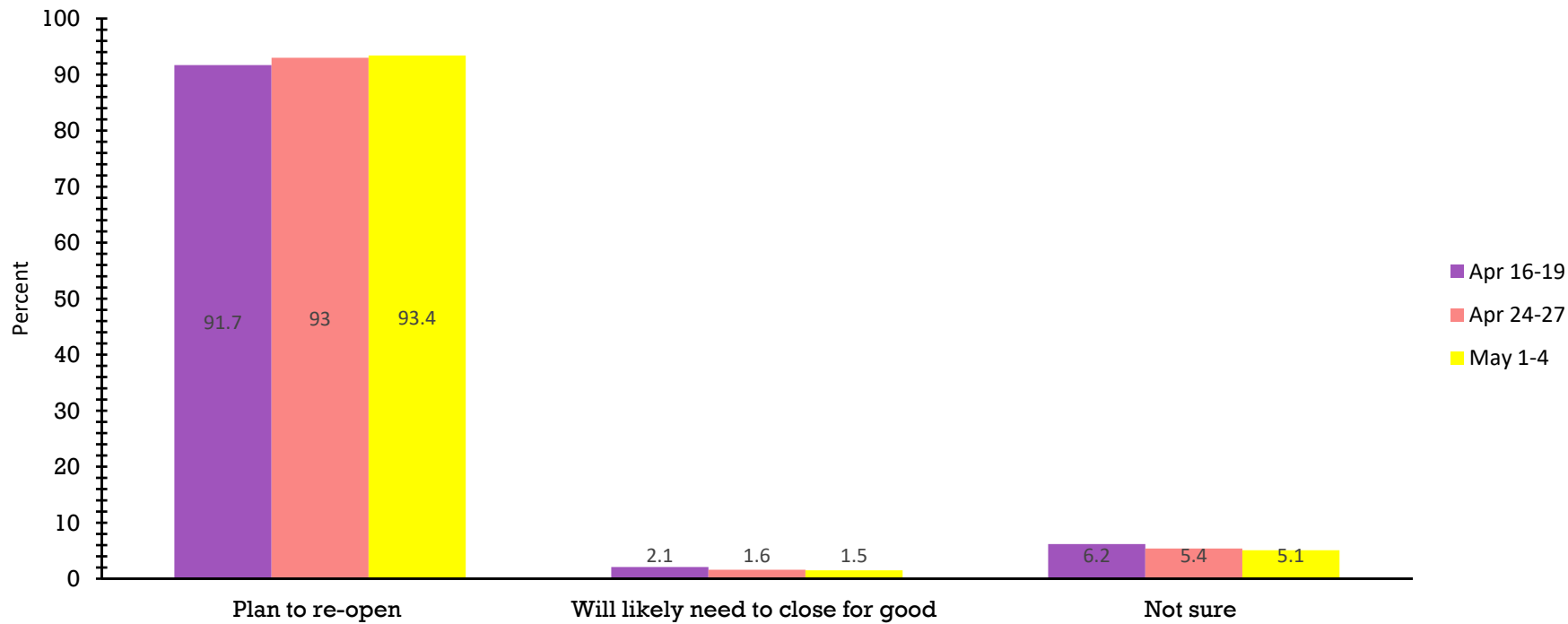

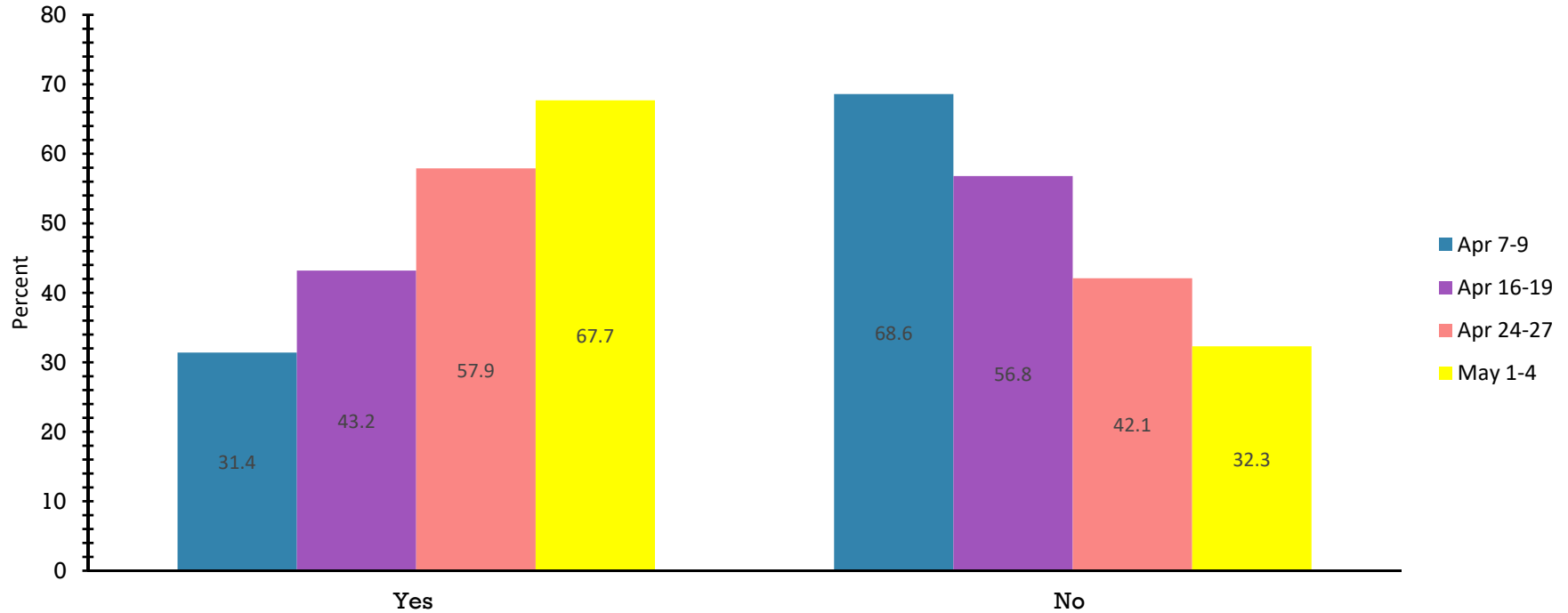

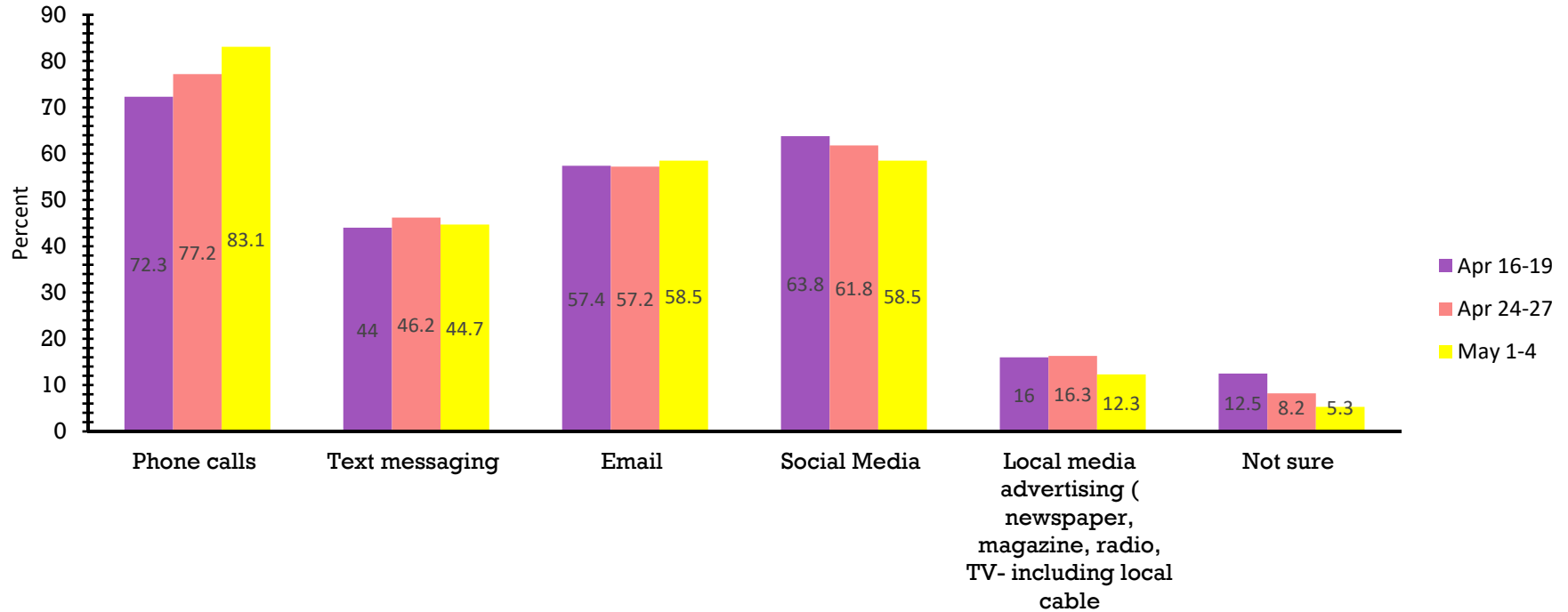

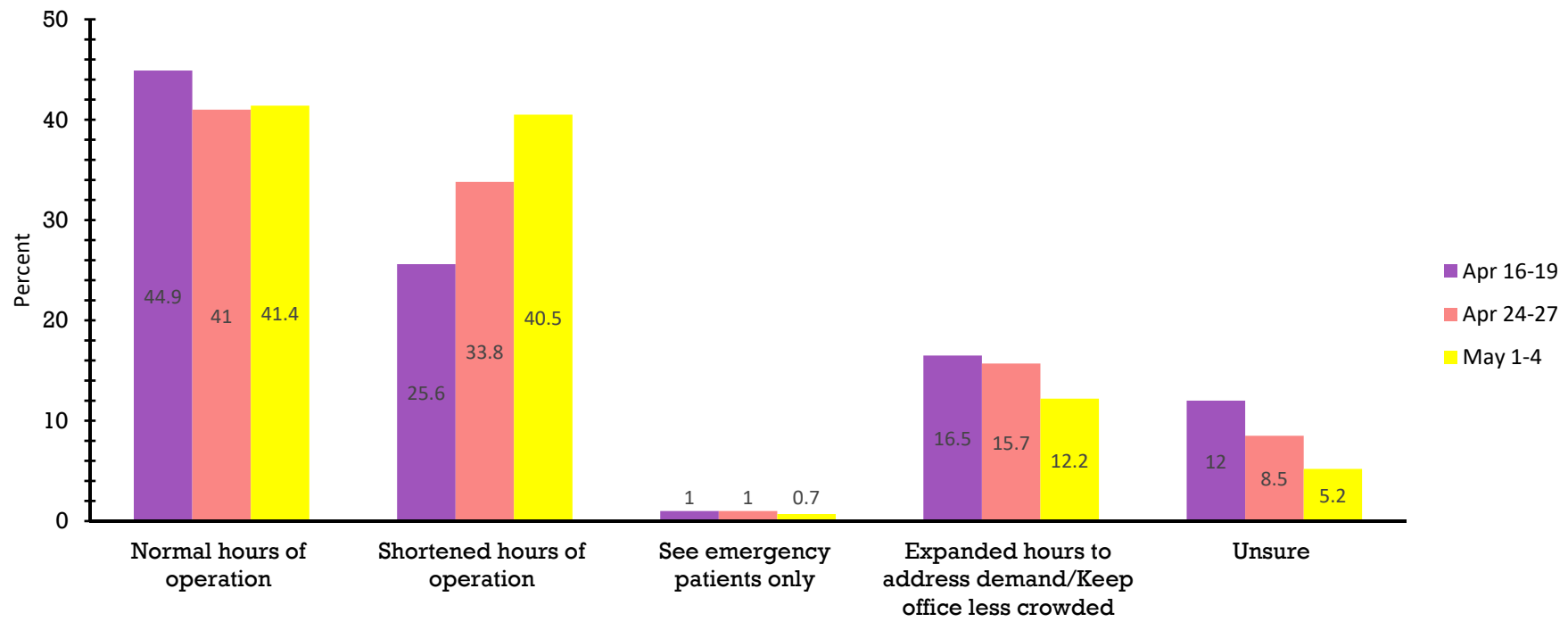

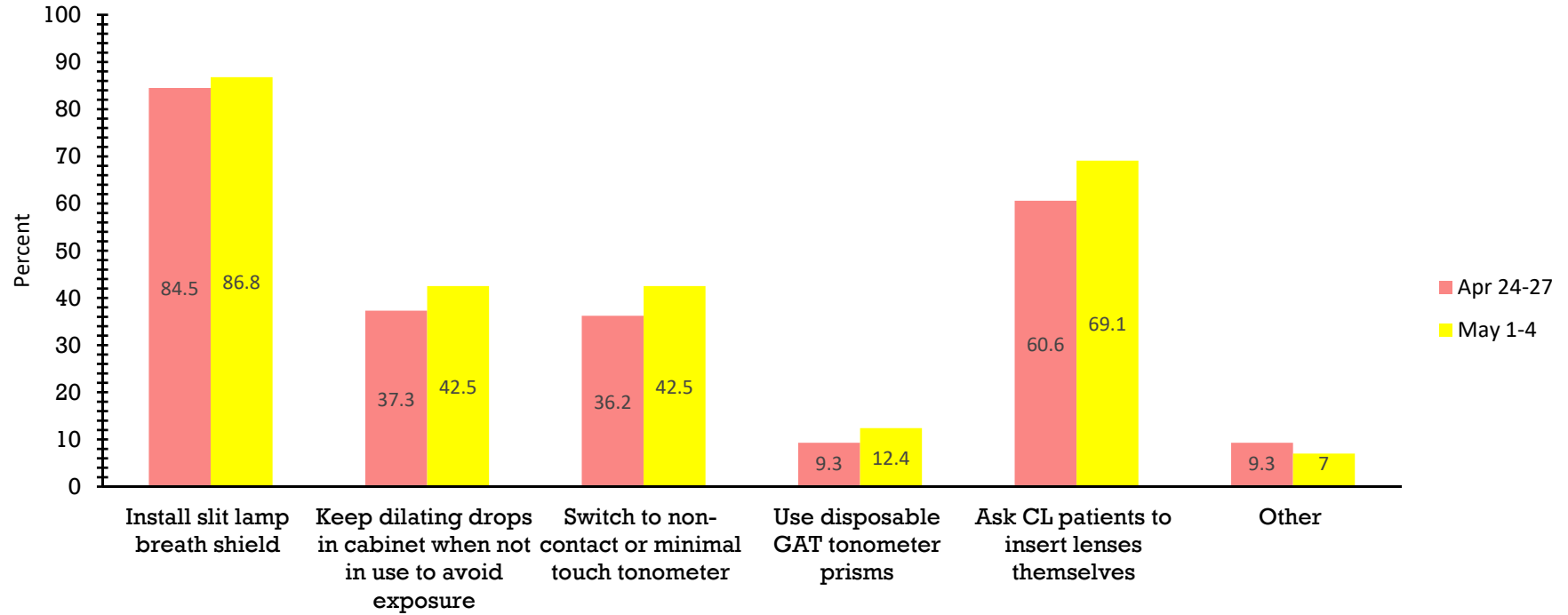

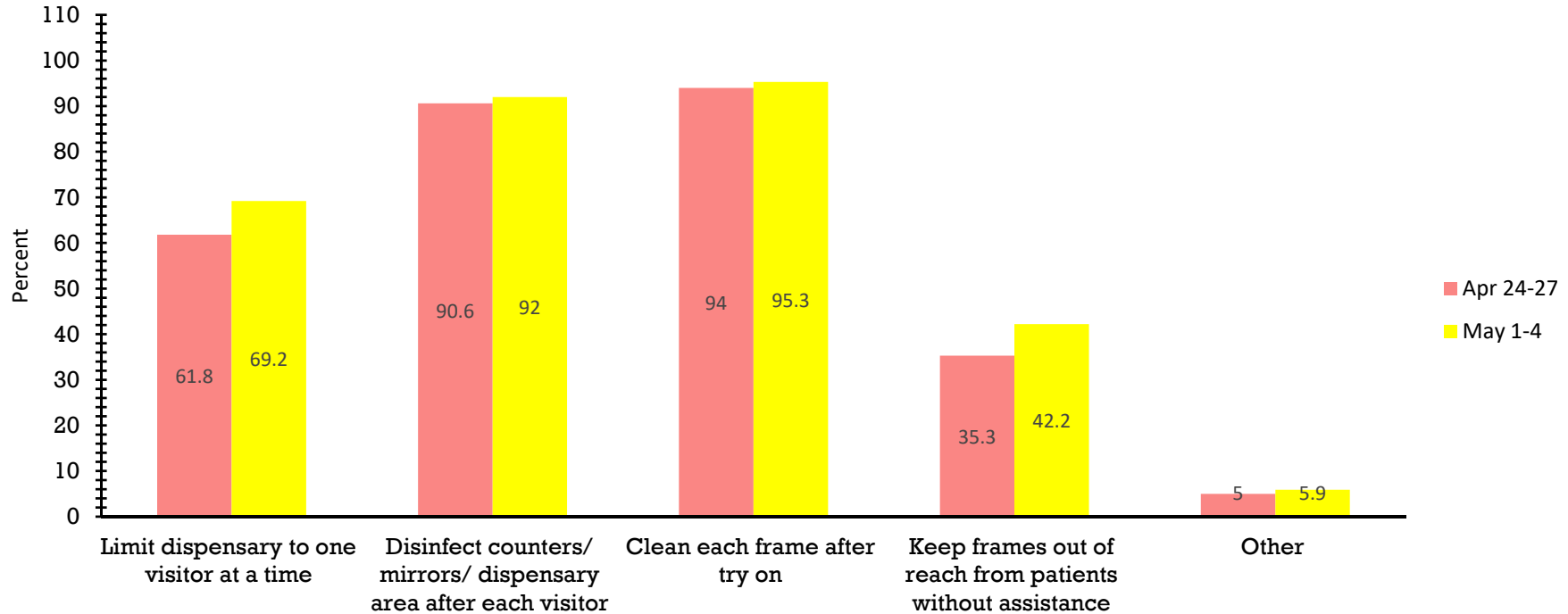

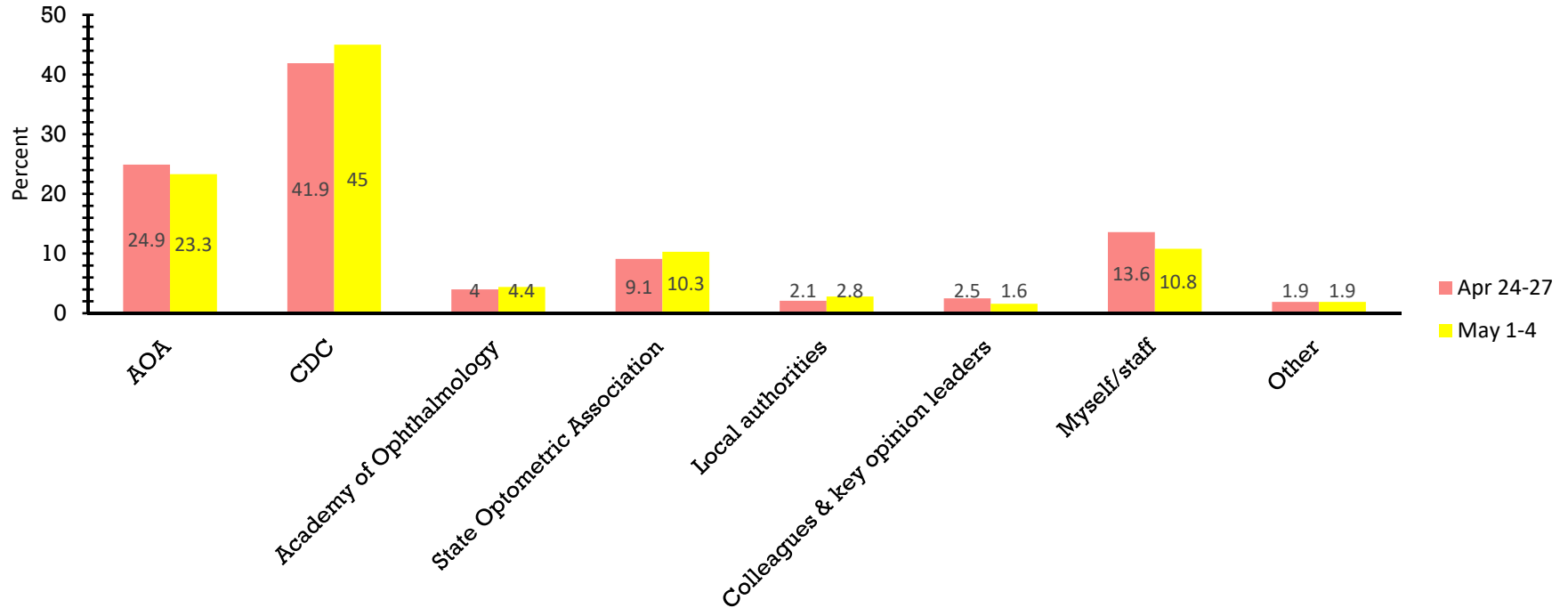

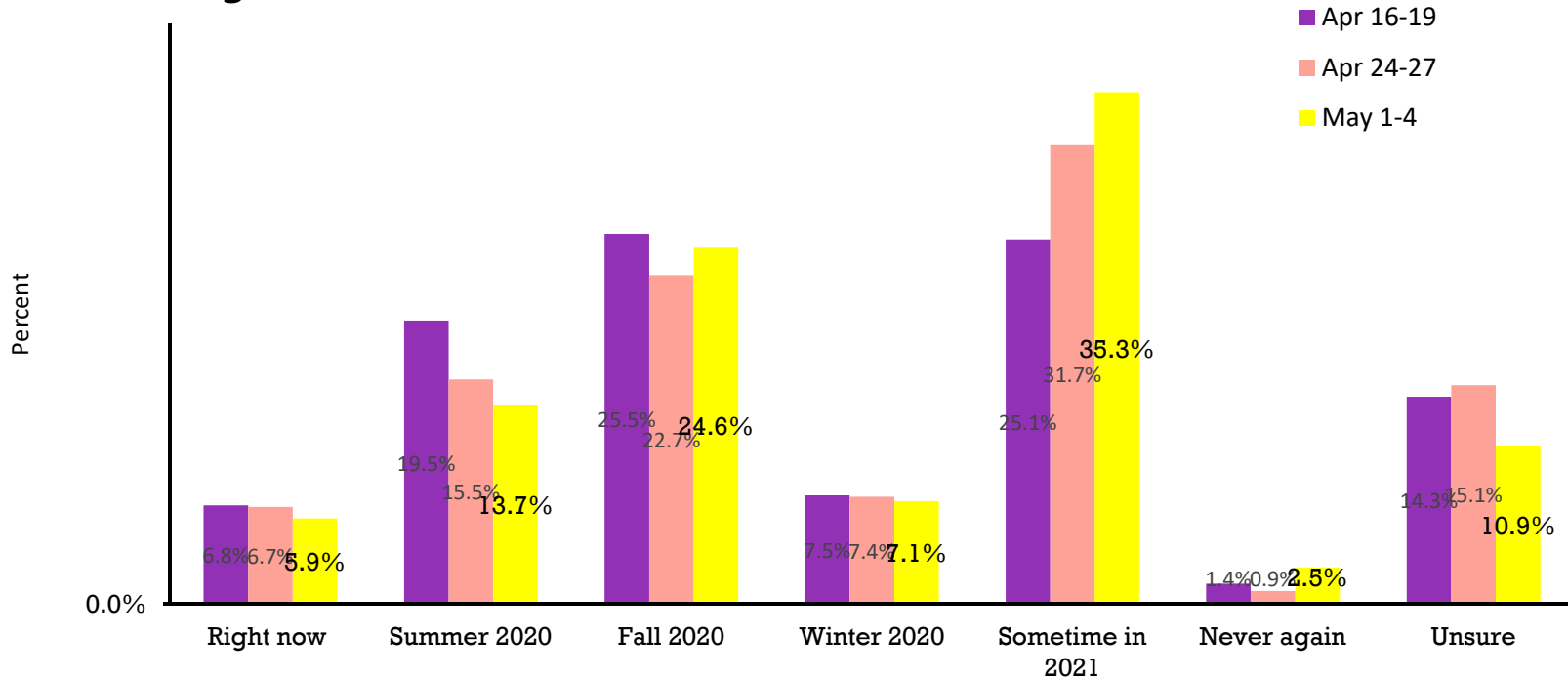
